Finally, a readable genealogy! *Hubbell By Choice* is a different type of family history because it traces thirty-six women, the three wives of the emigrant Richard Hubbell and the wives of his sons and grandsons back into England. Descendants of this Hubbell spell their name in five ways, and all trace to the same individual. The Hubbell / Hubble / Hubbel / Hubel / Huble families in North America. He came to the New Haven Colony from Rock, Worcestershire, England in the early 1640's.

Most genealogies consist of names, dates and places which can be boring reading. This book is full of pictures, maps, gravestones, churches, essays, paintings, related documents. There are also fascinating side bars and many short stories about what life was like in those early years. In addition, errors in other sources are noted and corrected. There is a wealth of recently discovered material.

There are three other Hubbell genealogies, which like most family histories, are focused on the male line. They only record the names of the Hubbell wives, their dates and their parents, when known. Even the spouses and children of the five daughters of Richard were never recorded in the Hubbell genealogies but are now included in *Hubbell By Choice*. Since we descend equally from our mothers, as well as our fathers, Marjorie Gibson and Mary Ann Hubbell decided it was time to bring our mothers out of obscurity and onto the pages of a book.

"Researching these women was very difficult because except for birth, marriage, death, land and court records, when available, often very little has been written about them. However, in some cases we were able to trace their ancestors back many generations which means that other family surnames have surfaced and been traced as well. For example, we were able to find the ancestors of Richard Hubbell's mother, Sarah Wakeman, back another three generations to the early 1500s, as we were able to do with a few other wives as well." Said author Marjorie Gibson. This 369 page 8.5 x 11 book will give the reader some insight and appreciation of our little known female ancestors and the era in which they lived and died.



Mystic Seaport: The Museum of America and the Sea

For those who grew up in southern New England, Mystic Seaport brings back memories of school trips to the museum, spending a day on a school bus travelling down to visit the tall ships and take a ride on the Mystic River. Founded in 1929 as the Marine Historical Association, it is now called Mystic Seaport: The Museum of America and the Sea and is the leading maritime museum in the United States. They are in the midst of a \$35 million renovation to improve not only the exhibit halls but the collections research center as well. Their website, www.MysticSeaport.org, contains a vast amount of information valuable to genealogists.

For genealogists with seafaring ancestors, nothing can replace a visit to the museum. After all, how many research repositories can you visit by taking a boat up the river and docking? Their collections are composed of many different parts. The Art & Objects Collection, for example, holds more than 7,000 paintings and prints, 1,600 nautical instruments, 1,150 ship models, 1,700 pieces of scrimshaw, and 100 figureheads. Some of these items date back to the sixteenth century.

The book collection contains 70,000 volumes, 2,000 rolls of microfilm, and 1,000 ship registers. Titles dating back to 1784 are among the 700 periodicals in the collection. There are more than 9,000 nautical charts and maps dating from 1650 to the present. The manuscripts collection contains hundreds of distinct collections of ships' logs, ledgers, diaries, documents, business and personal papers, correspondence, and design data. The collection documents the whaling, fishing, and shipping industries from the early eighteenth century to the present. More than 100,000 naval architectural drawings from 1827 to the present document the development of different types of vessels. These are complemented by more then 1.3 million photographs from 1840 to the present, the largest single collection of maritime photography in the world.

Like other institutions, Mystic Sea-

port is making parts of its collections available online to researchers. They have made available finding aids for manuscript and ship plans collections. Indexes to microfilms, oral histories, and their publication, *Log of Mystic Seaport*, can be viewed online as well.

They have several digital exhibits taken from various parts of their collections. For example, the 19th Century American Merchant Marine Digital Library makes more than 120,000 pages of material available online in image format. The exhibit starts with an introduction to maritime activities in American history and an explanation of the significance of this digital collection. This is followed by several bibliographies, including American Maritime Documents, American Maritime History, Forty-Niners 'Round the Horn, Nautical Instruments, and Sea Chanteys. There is also an FAQ list about maritime history, such as "How can I do vessel research at the G.W. Blunt White Library?" and "Where can I find print sources about scrimshaw?"

The next section has timelines of American Maritime History and U.S. Statutes relating to the regulation of American shipping between the American Revolution and the Civil War. The Digital Collection section allows you to browse by subject, title or by ship/yacht register. You can also search by ship/ yacht register or by keyword. Finally, there are four essays: "A Forty Niner Fourth of July," by Charles R. Schultz; "More Decency and Order: Women and Whalemen in the Pacific," by Joan Druett; "On Shore in a Foreign Land: Mary Stark in the Kingdom of Hawaii," by Richard C. Malley; and "Scenes in

Honolulu — No. 9 Sad Accident," by Mark Twain.

Most valuable for genealogists is the E-Reference section, with several online databases. The Ship and Yacht Register Lists cover registers from 1857 through 1900 and is searchable by vessel name or shipmaster. The Connecticut Ship Database, 1789-1939, comes from a WPA transcription

of U.S. Customs Service records and is searchable by vessel name and type or by person/company name. There are two crew list databases: one for New London, 1803-1878, and a second for Salem, Mass., 1799-1879. There is also the Seamen's Protection Certificate Register Database, with information on 31,047 certificates issued between 1796 and 1871 at the Customs Houses in Fall River, Gloucester, New Haven, New London, Newport, Marblehead, and Salem.

Finally, the E-Reference section also contains two browseable databases. The first contains images of many vessels used by immigrants to come to the United States, as well as general information on the ships themselves. You can order high-quality reproductions of the ship images directly from the site for a modest fee. The second is a list of items from the collections that have been digitized and are available to view online.

If your ancestors were involved in the sea through maritime service or through migration by sea in the eighteenth, nineteenth, or twentieth centuries, this organization will be very helpful to you. Visit their website, and if possible, schedule a visit this summer to the seaport itself. You will not be disappointed.



New Monument Dedicated at Memorial Day Service

It was a task no member of Metter's VFW Post 5893 ever wanted to undertake. But on Monday, during the annual Memorial Day service in the downtown park, the new monument, bearing the name of a fallen War on Terrorism soldier, was officially dedicated.

"Across the street this year, we've added two stones, nine lines, one name," said LTC Mark Cauley of VFW Post 5893. That name is of SSG E-6 Darren Hubbell, who died less than a year ago, on June 20, when an IED exploded in Iraq.

To the Hubbell family, Cauley said, "We are greatly honored by your presence today," adding that he hoped the family could find solace in the monument dedicated to the memory of their son and husband. And, he added, it is the prayer of the VFW that this is the first and last name that will have to be added to the monument.

More than 150 people attended the ceremony and the traditional placing of the wreath. Based on the support she has received from the local community, Darren's widow Dana said, "It's amazing." She added, however, that the attendance on Monday was just a reflection of the support she has received from the community since Darren's death, even since she moved to Statesboro.

"I still get so many calls of encouragement from Metter," she said. "People come up to me whenever they see me and hug me and say how they are thinking of me."

And, Dana said, she will need that support especially in the days to come, as the anniversary of Darren's death nears.

Darren and Dana were still newlyweds when he was called up for his fourth tour in the Middle East. He left on Mother's Day weekend, 2007, less than five months after the couple exchanged vows.

Darren, who was originally from southwestern Georgia, had moved to Metter, Dana's hometown, to be with his bride before his call for a 15-month tour.

His death a year ago was met with sadness and mourning by an entire community, many who did not personally know Darren, as crowds lined the streets of downtown Metter as his body was brought home.

Eleven months later, his mother, Darlene Larsen of Jacksonville, Fl., is still amazed at the community's outpouring of support.

"I have never seen anything like this," she said on Monday, adding, "One good thing is, I've been able to explore this little town. I had never heard of it, never knew it existed, but the support they have shown us ..."

Her husband, Kim Larsen, had similar thoughts. "It is kind of a sad occasion, but it is nice to see something that goes beyond the ribbon on the back of the car," he said. "It's nice to see a town that comes out and takes it a bit further. This is a remarkable place."

Families Struggle to Find Life After a Soldier's Death

Connie Bickers gave me simple directions to her house in St. Joseph, but the country roads in central Illinois all look the same and in the pitch black of a winter evening I get lost. I find her house when I see a memorial road sign labeled "Cory Hubbell Way." The sign was dedicated last October by Illinois Lt. Gov. Pat Quinn in honor of Bickers' son, who died while serving in Kuwait in 2003. He is the reason I'm here.

"Can I show you Cory's room?" Connie asks, leading me into a space filled floor to ceiling with memorabilia from her son's life. Awards and recognitions, his Army boots and his uniforms, an old football he tossed around in the desert signed by members of his unit, memorial quilts knitted by military mothers to honor his service, and Connie's collection of at least 30 angels that she began assembling after Cory's death at 20 years old.

"He was my angel," she says, fighting back tears. Time has not healed Connie Bickers' wounds.

"It's like every year it's just a little bit worse," she says. "I don't know if it's that reality is setting in because you know they're not coming home. ... It will be five years this year, and I'm starting to face reality that it's never going to happen."

A humble stone memorial in the front yard sits in the chilly evening, guarded by an American flag whipping in the wind. She gestures toward the dirt surrounding the memorial.

"In the spring, there'll be red, white and purple petunias," she says.

President's remarks:

Thanks to everyone for being here and to Eliot Fair for arranging the local meeting.

Frankenmuth final report is included in the Board book – successful in every respect.

Hilbert thanked Carol Boggs again for the work she did behind the scenes as president. Especially the administrative manual which Hilbert showed the Board. It is an impressive tome by Carol.

Minutes were Approved with three corrections – passed unanimously

Treasurer Report:

- * Income was up just a little.
- * Merchandise is working well. Jan acknowledges immediately sends things out the same day. This works really well. Pete faxes the order to Jan, she emails the next day to tell Pete it has been sent.
- * All of the income comes to Pete's treasurer account and he pays out to the Scholarship fund and Hubbell Center
- * Canadian dollar has come up and that has helped the balance.

Instructions:

- 1. Select two people in your family and figure out which ancestor they have in common. For example, if you chose yourself and a first cousin, you would have a grandparent in common.
- 2. Look at the top row of the chart and find the first person's relationship to the common ancestor.
- 3. Look at the far left column of the chart and find the second person's relationship to the common ancestor.
- 4. Move across the columns and down the rows to determine where the row and column containing these two relationships (from #2 & #3) meet. This box is the relationship between the two individuals.


When the word "removed" is used to describe a relationship, it indicates that the two people are from different generations. You and your first cousins are in the same generation, so the word "removed" is not used to describe your relationship. The words "once removed" mean that there is a difference of one generation. For example, your mother's first cousin is your first cousin, once removed. This is because your mother's first cousin is one generation younger than your grandparents and you are two generations younger than your grandparents. This one-generation difference equals "once removed." Twice removed means that there is a two-generation difference, three times removed equals three generations, and so on.

George Edward Hubbell Family Photo Album

Photo Sheds Light on Hubbell House History

Susan McClocklin of Rochester found a little piece of history while rummaging through her aunt's old family photos -- a rare interior shot of Mantorville's famed Hubbell House circa 1924. She and her cousin Sam Ellson of Kasson recently ate at the Hubbell House and compared the photo to the restaurant's current state.

They gave restaurant owner Don Pappas the photo to keep. "It was neat to

find the picture," McClocklin said. "Had it not been written on the back, I'm not sure I would have known it was the Hubbell House." According the back of the photo, the women pictured are "Grandma Ellson" and twins Doris and Dorothy Ellson.


Pappas has a fair amount of photos of the outside of the building, and two of the lobby. Pappas' family has owned the building since 1946. The original hotel and restaurant was built in 1854 out of logs and then was rebuilt in 1856 out of Mantorville limestone.

"You can see the deep window wells in the photo. The beams are the same now as they were then," Pappas said. "We even set

the table the same way."

He has a few copies of news articles from the late 19th century that speak of the Hubbell House, all of which mention the restaurant's great food, he said.


"It's really ironic how things have stayed the same," Pappas said. "It's bigger than any one family or owner. It seems like good food just goes with the place."



In 1931, young Ralph Gideon Hubbell (1909-2000; A&R# 9651) landed a job reading poems on WEBR in Buffalo, NY. This was within a decade of the birth of what would become one of the most powerful means of communication in history—radio! After a time Ralph moved to WBEN, where he would go on to become among the most respected sports broadcasters ever in Buffalo.

Hubbell began his sports career with WGR radio in 1939 and anchored his first television sportscast on Buffalo's Channel 4 in 1948. Ralph Hubbell provided color commentary during the early Bills years. Ralph Hubbell set the scene for the WBEN audience and play-by-play man Van Miller called the action for The 1964 AFL Championship Game where the Bills won their first of back-to-back championships.

Ralph Hubbell was a Member of The Greater Buffalo Sports Hall of Fame and The Buffalo Broadcasters Hall of Fame. Hubbell died September 14, 2000 at his home in Newfane, NY, just shy of his 91st birthday.
